## **Highwoods Declares Quarterly Dividends**

**RALEIGH, NC – February 4, 2020 – Highwoods Properties, Inc. (NYSE:HIW)** announces its Board of Directors today declared a cash dividend of \$0.48 per share of common stock for the quarter ended December 31, 2019, which equates to an annual dividend of \$1.92 per share and reflects a 1.1% increase over the prior quarter's dividend. This quarterly dividend is payable on March 10, 2020 to shareholders of record as of February 18, 2020.

The Board also declared a cash dividend of \$21.5625 per share of the Company's 8 5/8% Series A Cumulative Redeemable Preferred Stock. The dividend is payable on February 28, 2020, which is the next regularly scheduled dividend payment date, to shareholders of record as of February 17, 2020.
